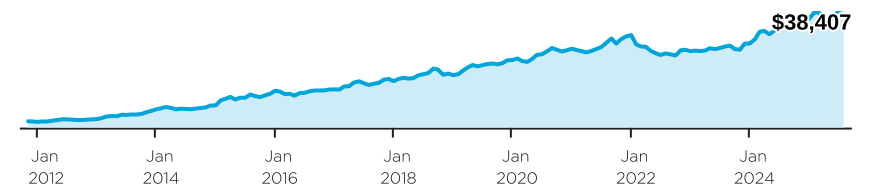

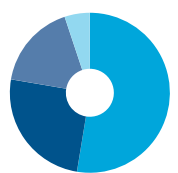

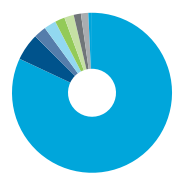


ASSET ALLOCATION<sup>4</sup>



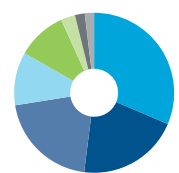
