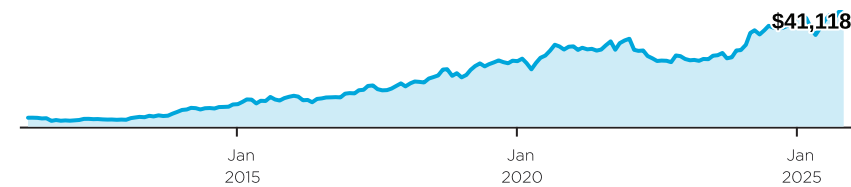

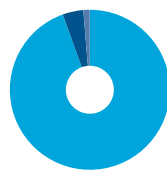
WHY INVEST IN DYNAMIC AMERICAN CLASS ?

GROWTH OF \$10,000 ¹

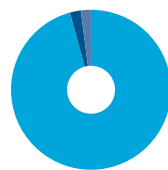


ASSET ALLOCATION



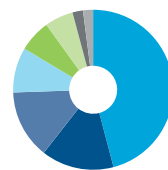
