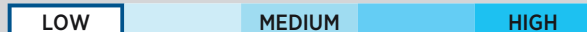

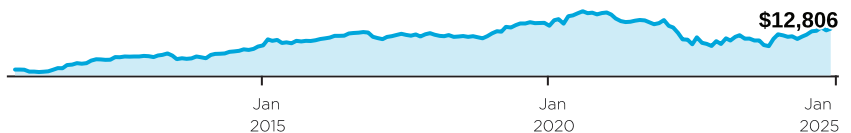

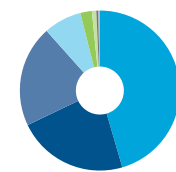
WHY INVEST IN DYNAMIC TOTAL RETURN BOND CLASS ?

GROWTH OF \$10,000

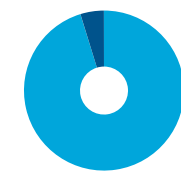


ASSET ALLOCATION



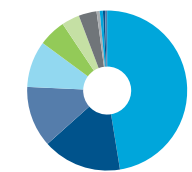
